- 3. Documents in support of qualification and relevant experience for the post shall be submitted in originals and one set Photostat copy for verification along with the resume, at the time of interview. After verification, the candidate must submit a set of Photostat copies of verified certificates and testimonials. Non-submission of documents/testimonials claimed in application, will lead to rejection of candidature.
- 4. Any candidate found guilty of impersonation or submitting fabricated documents or making statements, which are false or incorrect or attempts to use unfair means for the purpose of recruitment, shall be rejected.
